### Description and Uses

### When to use TANOPLUS AR FRESH® ?

Wines that are considered to be outside the acceptable range eg : all wines lacking of structure should be lab- treated with TANOPLUS AR FRESH®.

The treated wines can be tasted the same day of the treatment, however it is recommended to wait at least 48 hours.

Furthermore, revalue wines of average range at a lower cost.

It is recommended to use TANOPLUS AR FRESH® at a dosage between **2 et 15 g/hl** for red wine and between **2 et 7 g/hl** for white and rosé wine after dilution in wine. The dosage, and therefore the treatment cost, can be optimised by doing direct trials in bottles at different concentrations.
